### **JBCC ELECTRONIC SERVICE MODULE (JES)** (JBCC Contract Agreements)

3. JBCC Electronic Service – Architectural & Engineering version
  - (i) Reference, (ii) Active Forms & Schedules, (iii) Pay-as-you-go printing purchase (viii) Facilities (See Below)



### **PROCSA ELECTRONIC SERVICE MODULE (PES)** (Professional Agreements)

1. (i) Reference, (ii) Pre-paid purchase printing: Annexures completion & printing, (iii) Facilities (See Below)



### **CONTRACTUAL CLAIMS MANAGEMENT SYSTEM MODULE (CCMS)**

1. A software system which assists with processing of Contractual Claims, Notification and Assessment. For use by Principal Agents, Contractors and Subcontractors. Used specifically for claims for Delay, Expense & Loss and Adjustment of Preliminaries. Deals only with Claims relating to the JBCC Contracts.

### **CONTRACTUAL CORRESPONDANCE SERVICE MODULE** (Available in 2010)

1. A Software system which Contractors and Sub-contractors can download, that enables them to Produce standardised contractual correspondence.
